ENTRY REQUIREMENTS

- Applicants must be over the age of 18 to undergo licensing assessments
- Must present three (3) original evidence of identity documents
- Can use and interpret the English language that enables the safe performance of work
- Have sufficient literacy and numeracy skills
- Wear suitable clothing high-vis shirt, long pants, safety boots
- Have the physical capability to access and operate machine
- Have access to appropriate workplace, equipment and licensed WP operator to supervise and sign-off on additional workplace training
- Be ready and willing to study at night in order to have the best chance of successfully completing theory assessment

COURSE OVERVIEW

An elevating work platform is either a telescoping device, hinged device, or articulated device or any combination of these (with a boom length of 11 metres or more) used to support a platform on which personnel, equipment and materials may be elevated to perform work. The course largely focuses on a practical training approach providing participants with an engaging training experience. The high-risk licensing unit covers planning, routine checks, set-up, operations, shutdown and securing an EWP. Assessments are set by the Workplace Health & Safety Queensland licensing department and are conducted by an accredited licensing assessor.

After completion of training, a theory assessment will be completed, and learners are to return to the workplace to complete operations (recorded within a logbook) under the direct supervision of a licensed WP operator. Learners are required to complete logbook hours within 12 months of undergoing training. A final performance licensing assessment will be conducted after completion of theory assessment and logbook hours. It is the responsibility of the learner to source an appropriate workplace and licensed operator to sign off on logbook hours and to update Century Training on their progress and request assessments.

LICENCING ASSESSMENTS

Should a learner be unsuccessful during licencing assessment, they will be provided the opportunity to re-sit the assessment at a suitable time. Re-assessment fees apply. Should a learner cancel an assessment with less than 24 hours' notice, a re-assessment fee will apply.

COURSE OUTCOME

Upon successful completion, the candidate will be issued a nationally recognised Statement of Attainment and the required paperwork to apply online for a Workplace Health & Safety high risk licence class, WP.

OBTAINING A LICENCE

Successful candidates are required to submit an online application to Workplace Health & Safety Queensland who will issue a high-risk work licence. This application must be lodged within 60 days after the date of practical assessment. Any additional fees associated with this licencing requirement are at the expense of the applicant. Century Training will provide further instructions on this process upon course completion.

RECOGNITION OF PRIOR LEARNING (RPL)

Workplace Health and Safety does not allow RPL of high risk licences. All learners must complete training and assessment. If suitable documented evidence is provided of prior operations under an expired licence, the applicant may be able to use that evidence to reduce or eliminate the requirement of additional workplace training. Century Training in conjunction with Workplace Health & Safety require evidence of this experience. Enquire for further information on RPL.

LANGUAGE, LITERACY & NUMERACY SUPPORT (LLN)

Language, literacy and numeracy requirements for this course require the learner to be able to read, comprehend and write a limited range of texts in a familiar context. It requires the learner to carry out basic mathematical calculations. Century Training offers strategies to assist learners who may require support in these areas. Should a learner feel they may require assistance in these areas, please notify us prior to enrolment to discuss these options.
