# **ENTRY REQUIREMENTS**

- Can speak and interpret the English language
- Must be able to read, comprehend and write a range of English texts
- Must be able to carry out basic mathematical calculations
- Have the physical capabilities to access and operate EWP
- Applicants must be over the age of 18
- Must present 3 original evidence of identity documents to be sighted i.e. drivers licence, Medicare card, bank card

## **COURSE OVERVIEW**

This course commences with a full day training session specifying the skills and knowledge required to safely operate a boom-type elevating work platform (EWP) where the length of the boom is 11 metres or more. Boom-type elevating work platform means a telescoping device, hinged device or articulated device or any combination of these, used to support a platform on which personnel, equipment and materials may be elevated.

The course is tailored to suit those individuals who do not have regular access to an EWP in a workplace environment and cannot achieve workplace training. The course is scheduled for 3-days, however learners will be assessed on their practical abilities prior to undertaking licensing assessments. \*Should the trainer feel a learner requires further practical training after undergoing a skill pre-assessment, the learner may be required to return to the facility at the next available date to complete additional practical training session(s) before undergoing their final practical licensing assessment. Should this be required, a re-attendance fee may apply.

# **RECOGNITION OF PRIOR LEARNING (RPL)**

Workplace Health and Safety Queensland does not allow RPL of licensing assessments. However, if suitable documented evidence is provided of prior training / licensed operations, the applicant may be able to use that evidence to modify formal and workplace training. Such applications are to be made in writing and supporting evidence will be required. Workplace Health & Safety Queensland will be notified of such applications and reviewed in conjunction with the licensing department. Expired licences and licences from overseas jurisdictions are not recognised for full RPL, the assessment process must still occur.

# LANGUAGE, LITERACY & NUMERACY (LLN)

#### **FUNDING**

## LICENCING ASSESSMENTS

A candidate must be 18 years or over to undergo licensing assessment. Should a candidate receive an unsatisfactory result during assessment, they will be provided the opportunity to re-sit at a suitable time. Re-assessment fees apply.

#### **COURSE OUTCOME**

Upon successful completion, a nationally recognised Statement of Attainment and Workplace Health & Safety Queensland Assessment Summary (to apply for a high-risk WP licence) will be issued.

#### **OBTAINING A LICENCE**

Learners are required to submit an online application to Workplace Health & Safety Queensland who will issue a high-risk work licence. This application must be lodged within 60 days after the date of the candidate's successful practical assessment. Licensing fees apply and are to be paid direct to Workplace Health & Safety Queensland. https://www.worksafe.gld.gov.au/licensing-and-registrations/workhealth-and-safety-licences/licence-fees.
